

## Official Rules

### **Blizzard Entertainment's Diablo IV Season 1 Contest**

**1. Eligibility.** ACTIVISION BLIZZARD PTY. LTD. (ABN 90 054 096 883) (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST. THIS CONTEST IS OPEN ONLY TO RESIDENTS OF AUSTRALIA AND NEW ZEALAND WHICH ARE OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST. **If you are under the legal age of majority in your country of residence (a "Minor"), one of your parents or legal guardians must submit a signed, written statement that they have read, understood and agree to these Contest rules with your entry, and that such agreement constitutes acceptance of these Contest rules on behalf of you and themselves.** To be eligible to win a prize, entries must be completed and received by Sponsor in the format designated below. **3. Contest Period.** The Contest shall commence at **8:00 PM AEST 11 August 2023** (the "Start Date"), and shall continue in duration until **11:59 PM AEST 27 August 2023** (the "Deadline"). All entries must be received by the Deadline to be eligible to win a prize.

**4. How to Enter.** To enter the Contest, You must reply to the relevant giveaway post on Blizzard ANZ's Facebook or Twitter/X channel with a screenshot of your best Diablo IV Season 1 character transmog.

**5. Prizes & Winners.** Sponsor shall select three (3) qualified entrants as winners. Each winner will receive a Diablo-themed umbrella and a set of pins.

Winners will be notified via the social media platform they used to enter the giveaway after the Contest deadline.

Prizes returned as undeliverable or otherwise not claimed within fifteen (15) days after delivery of notification will be forfeited and may be awarded to an alternate winner. Prizes are not transferable. No substitutions or exchanges (including for cash) of any prizes will be permitted, except that Sponsor reserves the right to substitute a prize of equal or greater value for any prize.

**6. Sponsor Use of Entries.** You hereby agree that in consideration of your being allowed the chance to enter the Contest, you hereby grant the Sponsor a perpetual, non-exclusive, worldwide license and right to utilize the entry materials that you submit to Sponsor in connection with the Contest (collectively, "Entry Materials"). The Entry Materials will not be returned to any entrant. Without limiting the generality of the foregoing, you acknowledge that Sponsor shall have the right to use, modify, reproduce, publish, perform, display on all forms of media, distribute, make derivative works of and otherwise commercially and noncommercially exploit the Entry Materials in perpetuity and throughout the universe, in any manner or medium now existing or hereafter developed, without separate compensation to you or any other person or entity. You agree to take, at Sponsor's expense, any further action (including, without limitation, execution of affidavits and other documents) reasonably requested by Sponsor to effect, perfect or confirm Sponsor's rights as set forth above in this paragraph 6.

Original Work of Authorship.** You hereby warrant and represent that (a) you own all rights to all Entry Materials submitted by you; and (b) all such Entry Materials are original works of authorship on your part and have not been copied, in whole or in part, from any other work and do not violate, misappropriate or infringe any copyright, trademark or other proprietary right of any other person or entity.

**8. Collection of Information.** The Entry Materials include a survey that requires you to enter your name, e-mail address, and state of residence. By entering the Contest, you consent to Sponsor's use of this information to inform you of open positions with Blizzard, and to associate your name with your submission in promotional materials for the Contest in the event that you are chosen to be a winner. As stated above, the contest is not open to anyone under the age of majority in your country of citizenship. In the event that Sponsor becomes aware that you are under the age of majority in your country of citizenship Sponsor will delete, erase or destroy any and all personally identifiable information that is obtained from the Entry Materials. Upon request, you will be provided with access to your personal data. You also have a right of opposition to the data collection, under certain circumstances.
