Official Rules

Blizzard Entertainment's Sulfuras Replica Contest

1. Eligibility. ACTIVISION BLIZZARD PTY. LTD. (ABN 90 054 096 883) (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST. THIS CONTEST IS OPEN ONLY TO RESIDENTS OF AUSTRALIA AND NEW ZEALAND WHICH ARE OVER THE AGE OF MAJORITY IN THEIR COUNTRY OF RESIDENCE ON THE DATE REFERENCED BELOW AS THE START DATE FOR THE CONTEST.
