### **Call of Duty Social Media Promotion Terms and Conditions**

### 1. Promotion Details

Activision Blizzard Pty Ltd. (the "Promoter") is running a promotion, "Call of Duty: Black Ops 6 Contest" on Facebook and X ("Promotion"). # 2. Eligibility and Restrictions

The Promotion is open only to citizens and permanent residents of Australia and New Zealand who are 18 years of age or older or the age of majority in their jurisdiction, whichever is greater, at the time of entry.
