Blizzard Entertainment's Guardians of the Dream Custom PC Contest

- 1. Eligibility. ACTIVISION BLIZZARD PTY. LTD. (ABN 90 054 096 883) (referred to herein as "SPONSOR") IS THE SPONSOR OF THIS CONTEST.
